Kevin Lawrence Cole passed away on Thursday, July 7, 2011 at the young age of 56. He was the beloved husband of 23 years to Rebecca Nastasi Cole, and loving father of Kevin Michael Cole, Cheryl Cole, Kristin McAnelly and Alyson Cole Grifka.

As a young boy Kevin moved from Austin, Texas to Baton Rouge, Louisiana and made Mandeville his home for the past 33 years. Kevin received his Juris Doctorate in 1978 from Louisiana State University School of Law and was devoted to his legal career.
