### Representative Matters

- Summary judgment obtained by Galloway on behalf of a Jackson, Mississippi restaurant in a case where plaintiff was claiming to have been shot in the restaurant's parking lot. Additionally, the Court awarded sanctions against the paraplegic plaintiff and in favor of Galloway's client relative to discovery violations committed by the Plaintiff during the course of litigation.
- Secured early dismissal in favor of Mississippi-based medical transport company, where plaintiff alleged she was mishandled during an arrest by various individuals, including law enforcement officials.
- Secured dismissal with prejudice in a coverage dispute between two insurance carriers necessitating interpretation of the MCS-90 endorsement following a tragic collision involving an 18-wheeler that was not listed as a covered auto on any insurance policy.
