Eating, Shopping... Science? How Biomechanics and Injury Causation Can Assist in Evaluating Claims

Biomechanics uses engineering and physics principles to study injuries to the human body and the mechanisms of those injuries. In this presentation, Dr. Serina and Mr. Girvan will demonstrate the use of biomechanical engineering principles in cases with injury claims, using case studies of commonly seen premises liability actions such as falling items, slip-and-fall and collapsing chairs.
